WHEREAS, the Board reviewed the proposal and found to be acceptable;

NOW, THEREFORE, BE IT RESOLVED, that Tropitone Furniture Co. Inc., 32992 Collection Center Drive, Chicago, IL 60693 be and hereby is engaged in accordance with their bid in the amount of \$54,066.70.
